## TEXT to 911 SERVICE AVAILABLE IN CUMBERLAND COUNTY

If you are in an emergency and cannot safely make a voice call, you can text 9-1-1 for help.

- 1. Begin by starting a new message to the number 911.
- 2. Be sure to type your exact address/location and any emergency details.
- 3. Follow instructions given to you by the responding dispatcher.



#### MEDICARE ADVANTAGE OPEN ENROLLMENT PERIOD (MA OEP)

The Medicare Advantage Open Enrollment Period (MA OEP) is the time when you can switch from one Medicare Advantage Plan to another, or switch from a Medicare Advantage Plan to Original Medicare with Part D plan. The MA OEP occurs each year from January 1 through March 31, and changes take effect on the first month of the month following the month you enroll. You can only make one change during the MA OEP. ## PHARMACUTICAL ASSISTANCE TO THE AGED AND DISABLED (PAAD)

The Pharmaceutical Assistance to the Aged and Disabled (PAAD) program is a state-funded program that helps eligible older adults and individuals with disabilities save money on their prescription drug costs.

PAAD provides coverage for prescribed legend drugs. The PAAD co-payment will be \$5 for each covered generic drug prescription and \$7 for each covered brand name drug prescription. PAAD beneficiaries may pay less for generic drugs if their Medicare prescription drug plan charges them less than the \$5 PAAD copayment for generics. Also, PAAD can help pay the premiums for certain Medicare Part D plans.

The income limits for PAAD are expected to increase in 2026. These income limits also apply to the Lifeline Energy Assistance Program. This program provides a once yearly \$225.00 utility credit or check for your gas and electric costs.

#### SENIOR GOLD PRESCRIPTION DISCOUNT PROGRAM

The Senior Gold Prescription Discount Program (Senior Gold) is a state-funded prescription program with a different copayment structure and income eligibility guidelines than those of PAAD.

Senior Gold benefits help to make Medicare prescription drug coverage more affordable by reducing any other out-of-pocket costs associated with that coverage, such as deductibles, co-insurance, and the coverage gap known as the "donut hole."

Members receive assistance for prescribed legend drugs and pay a copayment of \$15 plus 50% of the remaining cost of each Senior Gold covered drug.

Once members reach the annual out-of-pocket expenses, they pay only a flat \$15 copayment per prescription for the balance of that eligibility period.

The income limits for the Senior Gold Program are expected to increase in 2026.

## LIHEAP AND UTILITY ASSISTANCE PROGRAMS

Applications are still being accepted for the Low Income Home Energy Assistance Program (LIHEAP), which assists with heating expenses during the winter and cooling assistance for those with medical need; and the Universal Service Fund (USF) which provides year-round assistance with utilities expenses. LIHEAP income guidelines for a household of one is \$4,167 per month; \$5,449 per twoperson household; \$6,732 per threeperson household; etc. Documentation required to apply for LIHEAP includes: identification for the applicant, Social Security card for each household member, current income for each household member, proof of residence (lease, deed, or tax bill), a current heating bill with applicant's name and address (or a completed Tenant Verification Form provided by this office if electric is included in the rent.). Required documentation for cooling assistance includes a current electric bill. and a completed doctor's certification form for new applicants or if the previously submitted doctor's certification was submitted more than 5 years prior. For extra assistance with utility expenses, the Universal Service Fund (USF) is also available, using the same income guidelines as provided above. **NOTE:** Vineland Electric customers are not eligible for this program.

Anyone who received LIHEAP during 2024-2025 assistance the application season should have received a recertification form through the mail.
